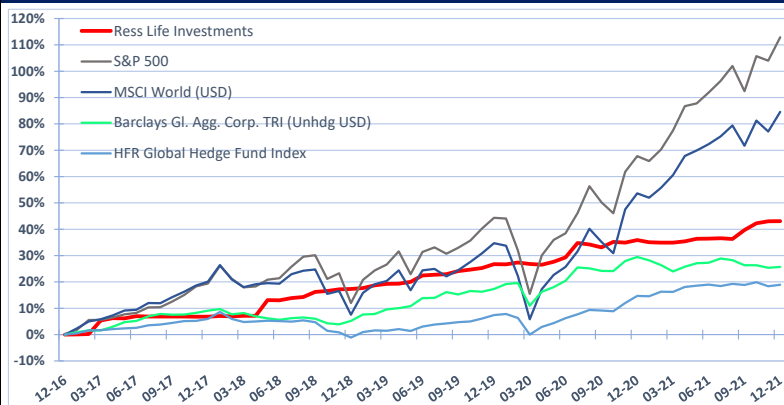

MANAGER'S COMMENTS

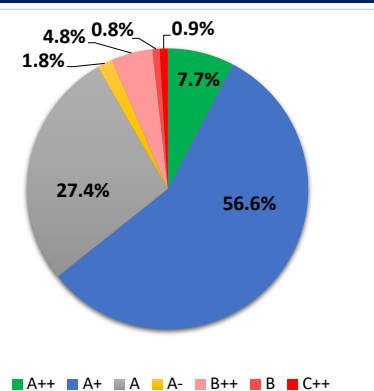
The net return of Ress Life Investments was 0.0% in US dollars in December. The net return year to date is 5.3% in US dollars. The net annual return in the last five years is 7.4% in US dollars and the Sharpe Ratio is 1.5. Thus, Ress Life investment has during the last five years delivered in line with our expected return of 7% per year.

Ress Life Investments has seen strong interest from investors during 2021, and assets under management is now above 300 million US-dollars. We continue to see a good supply of insurance policies coming to the secondary market in the US. Therefore, we expect to further expand our investments during 2022. This will benefit the diversification of the portfolio, increasing the probability of a continued good risk-adjusted return for the Fund.

INVESTMENT OBJECTIVE AND STRATEGY

Investment Objective: Ress Life Investments aims to provide long-term uncorrelated returns in US dollars with a low volatility.

Strategy: Ress Life Investments selectively purchases US life insurance policies. The primary strategy is to hold the insurance policies until they pay out. The secondary market offers investors the opportunity to acquire life insurance policies at a discount to face value.

The investment manager has developed proprietary models for portfolio management and pricing in order to optimise returns when purchasing policies. Resscapital also collaborates with medical experts to assess longevity calculations on each policy acquired.

Target: Annual net return of 7% in US dollars.

WHY INVEST?

Risk diversification: Longevity, the main risk factor, is uncorrelated to equities, hedge funds and most other financial risk factors.

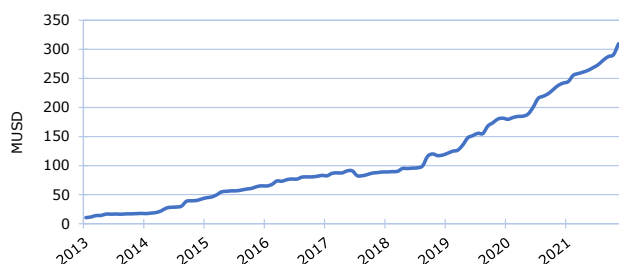
Alternative fixed income: The risk characteristics are similar to fixed income investments, but with a higher expected return

Stable performance: Realised volatility is 4.1% and the Sharpe ratio is 1.5 during the last five years.

Capital preservation: The strategy is suitable for investors where capital preservation is a key consideration.

Exchange-traded: Ress Life Investments is listed on Nasdaq Copenhagen and a market-maker provides daily prices.

RISK MANAGEMENT

Policies are thoroughly analysed and at least two expert opinions are obtained on life expectancies, prior to purchasing. Portfolio risks and limits on portfolio diversification across insurance companies, life expectancies, age groups, etc. are monitored continuously. Resscapital only transacts with brokers who are registered and authorised, and all brokerage fees must be disclosed in a clear and transparent manner to the seller.

Diligent credit risk assessment with limits on each insurer has created a diversified life insurance portfolio. Policies are issued by over 50 different US life insurers. Over 90 % of the policies are issued by insurance companies with a credit rating of A or higher (AM Best).
